- Raft of recent construction case announcements
- £67 million fines
- Range of sectors and business types implicated
- 11 directors disqualified
- 2 criminal convictions
- New CMA case studies & blog
- A risk to be taken seriously...



Real risk of getting caught



CMA is keeping a close watch on the sector



Investigation powers:

- 'Dawn raids'
- Interviews
- Requiring companies to provide us with documents and information
- Surveillance Powers
- Covert Human Intelligence Sources
- Communications Data

What is a business cartel?

- some examples



Price fixing



Market sharing



Agreeing with competitors what price you will charge, or what discount you will give, to avoid having to compete with each other

Agreeing not to go after a competitor's customers, or deciding which territories each business will 'take'

Also:

- Exchanging commercially sensitive pricing information
- Agreeing to limit production

Bid-rigging



Agreeing with other businesses how much you will bid in a tender, and who will have the lowest bid so that they win the contract

Evidence: Price fixing and market sharing

Secretly recorded evidence from cartel meeting




Evidence: Close knit industry



"... we're in at 2015 rates so perhaps we both move back to previous years to keep Mabey away."


A text in response said:

"Yes, I think that's the most sensible course of action given their current behaviour. Will do that today. Thanks"



Evidence: Cover bidding





"...he (the commercial property agent) wants us to quote this [...] job, but do you want to do a [expletive] plan and exorbitant cost for us...

"This is what we need another (bid) for. It needs to be rubbish and ultimately not work."



Director disqualification



- 25 disqualifications since 2016
 almost half of these in construction
- we actively consider director disqualification in all cartel cases
- serious implications for all companies



Coming forward for leniency



Rewards are significant for cooperating businesses and directors/employees where conditions are met

For businesses who report first and before we have started investigating, guaranteed:

- immunity from fines,
- protection from criminal prosecution, and
- protection from disqualification for directors

Reduction of fines, immunity from director disqualification and scope for criminal immunity for those who are not 'first in' or who come in first but after our investigation has started
